23. What instructional programs or course offerings have had the greatest impact for students during the 2021-2022 school year (implemented or continued)? *

Flexible Time, The Early Intervention Program, Extended Learning Programs, and Project Based Learning had the greatest impact for students during the 2021 – 2022 school year. Through these programs students were afforded extra time in core subject areas of reading, writing and math content. Through PBL students developed cross curricular STEAM competencies as teachers applied 21 Century teaching strategies through inquiry-based learning. The Schoolwide Enrichment Model provided enrichment in the core curriculum areas by bringing students into contact with experts and community leaders who explain how education connects to real life experiences. Comparative analysis of i-Ready benchmark data with end of school year data showed Typical Growth at 100% in Reading for grade K-8 and 89% Typical Growth in Math. The Main Street Academy also performed above several schools in the affiliated Fulton County School zones on the GMAS state assessment. In addition, 25% of eighth graders earned 1.5 high school credit hours through Algebra 1, 9th Grade Literature and Physical Science courses.

24. What instructional best practices has your Charter School implemented or continued for the 2021-2022 school year (e.g., data driven instruction, differentiated instruction, online or virtual courses)? *

At The Main Street Academy, we implemented extended time, high-dose small grouping, and frequent diagnosis of student performances using IXL independent online platform and project-based learning. Common assessments, in Language Arts and Math, were given at the end of every unit to assess learning. Instructional decisions were made based on the data.

25. What instructional or programming adjustments did you have to make during the 2021-2022 school year in response to ongoing COVID pandemic? *

During the 2021- 2022 school year The Main Street Academy acquired enough technical student devices to ensure one-to-one laptop usage for all scholars during the pandemic. During times of high community spread and when schools were forced to close, TMSA scholars were able to pivot to schoolwide virtual learning using OTUS learning management system and Microsoft Teams to support virtual classroom platforms. The Main Street Academy partnered with MAKO Medical to conduct onsite COVID testing and surveillance twice weekly.

During the 2021 School year TMS increased the amount of in-house professional development in Math and Reading/Language Arts and instructional technology.

Increased the number of teachers with STEM and Dyslexia Endorsements. Project Based Learning professional development was implemented schoolwide to support teacher development in 21 Century teaching and learning skills. More effective monitoring of teaching practices using TKES and LKES. Using instructional coaches, we supported the evaluation of appropriate resources based on the needs of the school. Coaches also supported the evaluation and appropriateness of available resources while also seeking additional resources to support the school and individual teacher goals. 27.
