• CCRPI Waiver (March 30)

The United States Department of Education (USED) on Friday approved Georgia's waiver of accountability requirements – including having to produce a College and Career Ready Performance Index (CCRPI) summary for the state, school districts, and schools. USED did not approve Georgia's request to waive state assessments altogether for the 2020-21 school year, which means the Georgia Milestones are required to be administered this spring, but the results will not be summarized by school or district into a CCRPI score.

• Math Standards Review

Proposed math education standards open for 30-day public comment period $\underline{\text{SURVEY LINK}}$

The Georgia Department of Education has posted the K-12 Mathematics Standards for review for a 30-day public comment period. If approved, the standards will be implemented in the 2022-23 school year. Throughout the 2021-2022 school year, teachers will receive training and professional learning, new resources will

be developed, assessments that are aligned to these standards will be developed, and communication will be provided to parents to ensure a smooth transition.
